### **Board of Directors Election**

As required by the bylaws of Willow Pointe Condominium Association, this announcement serves as notice to Homeowners of Willow Pointe Condominiums of the Election of Directors for the Homeowners Association.

In April 2018 three Board of Directors' terms will expire. Elections will be held to fill these three positions for a term of 3 years.

The Nominating Committee has qualified and nominated the following individuals to each serve:

- Vacant Position

Nominations may be made from the floor at the annual meeting. To qualify, nominees must, as a minimum:

- be willing and able to serve,
- be in good standing with the association, to include fees and assessments paid and no pattern of recurring Rules and Regulations violations,
- have no Conflict of Interest with Board Membership and Policies.

Any Nominee whose qualifications fail minimum qualifications will be deemed unqualified. If elected, the Nominee will be removed from the Board with no further cause and replaced by vote of the remaining Directors for the remainder of that Nominee's term.

Election to the Board of Directors shall be by secret written ballot. Members or their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of the Declaration. The persons receiving the largest number of votes shall be elected. Cumulative voting is not permitted. If your dues and assessments are not current you will not be permitted to vote.
